- 10.01 - 50 acres = \$400
- 50.01 - 100 acres = \$500
- 100.01 - 200 acres = \$700
- 200.01 or greater acres = \$1,000

Note: For all requests, professional service fees from the Village Engineer, Zoning Administrator and Attorney are the costs of the applicants / property owner per Section 17.17(6)(b) of the Village of Palmyra Zoning & Development Code.
